Key Points of Relevant Statutes

Illegal Street Racing

A.R.S. 28-708 (link to full statute: https://www.azleg.gov/ars/28/00708.htm)

- Driving AND/OR participating in street race is illegal (even if just there to watch or phone record)
- One or more vehicles comparing vehicle's acceleration, speeds, or time limit within certain distance
- Must be on a street or highway (Reckless driving would apply on private property / parking lots)

Misdemeanor

Aggressive Driving

A.R.S. 28-695 (link to full statute: https://www.azleg.gov/ars/28/00695.htm)

- Speeding AND 2 or more violations from list below (on road/highway)
- o Disobeying traffic control device
- o Passing on right by driving off pavement
- o Unsafe lane change
- o Following too close
- o Fail to yield right of way
- o And the behavior is an immediate hazard to another person or vehicle Misdemeanor

Reckless Driving

A.R.S. 28-693 (link to full statute: https://www.azleg.gov/ars/28/00693.htm)

- Can be on Public AND/OR Private property
- Reckless disregard for safety of persons OR property

Examples: donuts, burnouts, multiple traffic violations, wheelies

Key Points of Relevant Statutes

Impounds

A.R.S. 28-3511 (link to full statute: https://www.azleg.gov/ars/28/03511.htm)

- Shall impound for Reckless Driving
- Shall impound for Racing on Highways Shall impound if person uses vehicle to Obstruct Public Thoroughfare (blocking streets to facilitate street racing)

Impound Timelines

• For racing and reckless driving, vehicle is impounded for 20 days.

Obstructing Public Thoroughfore is only im

Obstructing Public Thoroughfare is only impounded for 7 days.

Questions & Answers

Question: What is an illegal street race (racing on a highway)?

Answer: In short, an illegal street race is when motor vehicles are engaged in a contest of speed. See Arizona Revised Statute (ARS) 28-708 for a more in-depth explanation.

Question: What is a street takeover or sideshow?

<u>Answer</u>: A street takeover or sideshow is when a group of drivers blocks an intersection while doing doughnuts, burnouts, and drifting.

<u>Question</u>: What has TPD done about these issues?

<u>Answer</u>: In 2021, TPD noted an increase in street racing. Several regional deployments have been conducted resulting in numerous arrests. These deployments focused on large scale gatherings and *illegal racing*.

After a street takeover in August 2022 at Pantano and Escalante, we switched tactics to cultivate intelligence on potential events and deploy large numbers of staff to prevent and minimize *street* takeovers.

Question: What do I do if I see an illegal street race or street takeover?

Answer: If you are witnessing an illegal street race or street takeover, call 9-1-1 and report the activity. Try to avoid the area in the case of a street takeover and do not confront participants/ spectators.

<u>Alternative reporting</u>: <u>Traffic Watch</u>, an online form which an officer reviews to later contact the registered owner of the vehicle.
